GIVEN the project TNE23-00019 "Italy–East Asia Cooperation: from Local Expertise to a Global Outlook" (LEGO) financed within the PNRR *Missione 4 "Istruzione e Ricerca" – Componente 1 "Potenziamento dell'offerta dei servizi all'istruzione: dagli asili nido all'Università Dalla ricerca all'impresa"- Investimento 3.4 "Didattica universitaria e competenze avanzate" T4 "Iniziativa Transnazionali in materia di istruzione"*, supported by the *European Union, NextGenerationEU - CUP H71I24000300002*;

HEREBY DECREES

the publication of this call for application for the allocation of **8 scholarships**, each with a **maximum amount of € 6.540,00**, for **teaching mobilities** at one of the partner Universities listed above. The duration of each mobility is one month.

Art. 1 - Recipients

This call is addressed to professors and researchers (RTDA, RTDB and RTT) of Politecnico di Milano, invited to carry out teaching activities at one of the partner Universities, in collaboration with local faculty. The researcher's contract must be valid for the entire duration of the mobility period and must not be covered with funds that are incompatible with PNRR funds (double funding is not permitted). During the mobility, the development of joint research activities on LEGO project topics is strongly encouraged, with the aim of producing joint publications.

Art. 2 - Application submission

Applications must be submitted via the following [online form](#) by **July 4, 2025**.

Applications must include:

- a curriculum vitae
 - a mobility agreement, to be completed using the template attached (Annex 1)
- Incomplete or late applications will not be considered.

Art. 3 - Selection procedure

Applications will be evaluated by a selection committee based on:

- motivation of the mobility in the context of the [TNE-LEGO project](#)
- overall objectives of the mobility:
- foreseen activities
- expected outcomes and impact.

In case of equal score priority will be given to the youngest professor.

Selected applicants will be notified by **July 31, 2025** and must confirm acceptance of the scholarship within the given timeframe.

Art. 4 - Contributions

The scholarship will be granted, as a business trip reimbursement, upon submission of receipts for travel, accommodation and board incurred during the mobility at one of the partner Universities, according to "POLITECNICO DI MILANO WORK TRIP REGULATIONS".

The maximum reimbursable amount is € 6.540,00. Traceable payment methods are recommended.

All mobilities must be completed, and reimbursements processed, by March 31, 2026.
