HEREBY DECREES

Art. 1 - Recipients

This Call is aimed at all students who have been nominated by their home University for an exchange period at Politecnico di Milano and don't receive any other contribution from Politecnico di Milano.

Art. 2 - Application submission

To participate in the selection process, students will have to fill in the form available at the following link https://forms.gle/xAMkPvMZkhzwKjiM8 within **June**, **6**th at midday. A motivation letter for the mobility at Politecnico di Milano (at most 3.500 digits) and a curriculum vitae in pdf format are required to complete the application.

Art. 3 - Selection procedure

A specially appointed commission will evaluate the applications considering the student's motivation letter and curriculum vitae.

Art. 4 - Contributions

The scholarship will be awarded, as a reimbursement, upon submission of expense receipts documenting the costs of travel, board and lodging incurred for the mobility period at Politecnico di Milano.

Only expenses made through traceable payment methods will be recognized for a maximum amount of \leq 3.000.

Art. 5 - Responsible for the procedure
